- 3. I further understand and agree that it is standard procedure that all daycare/boarding dogs are current with a flea and tick preventative, and that dogs nails are to be maintained and furthermore dogs who are found to have fleas or ticks will be bathed and nails will be cut at the owner's expense. All shots required by *Devil Dog Daycare, LLC* will be kept up to date.
- 4. I further understand and agree that *Devil Dog Daycare*, *LLC* and their staff, interns and volunteers, will not be liable for any problems that develop, provided reasonable care and precautions are followed, and I hereby release them of any liability of any kind whatsoever arising from my dog's/dogs' attendance and participation at *Devil Dog* Daycare, LLC.
- 5. I further understand and agree that dogs can sometimes receive minor cuts, scratches and puncture wounds at daycare. Since the dogs are intermingling, there is a chance that your dog may contract a contagious condition such as kennel cough. Any problems that develop with my dog(s) will be treated as deemed best by staff, interns, volunteers or Devil Dog Daycare, LLC, at their sole discretion. A veterinarian will be contacted if deemed necessary, and I assume full financial responsibility for any and all expenses involved.
- 6. I further understand by allowing my dog(s) to participate in services offered by Devil Dog Daycare, LLC I hereby agree to allow Devil Dog Daycare, LLC to take photographs or use images of my pet in print form or otherwise for publication and/or promotion.
- 7. I further understand my dog(s) must be licensed in the town in which he/she lives.
