1. I understand that I am solely responsible for any harm caused by my dog(s) while my dog(s) is/are attending *Devil Dog Daycare, LLC*.
2. I further understand and agree that in admitting my dog(s) to *Devil Dog Care, LLC, Devil Dog Daycare, LLC's* staff have relied on my representation that my dog(s) is/are in good health and has/have not harmed or shown aggressive or threatening behavior towards any person or any other dog.
3. I further understand and agree that it is standard procedure that all daycare/boarding dogs are current with a flea and tick preventative, and that dogs nails are to be maintained and furthermore dogs who are found to have fleas or ticks will be bathed and nails will be cut at the owner's expense. All shots required by *Devil Dog Daycare, LLC* will be kept up to date.
4. I further understand and agree that *Devil Dog Daycare, LLC* and their staff, interns and volunteers, will not be liable for any problems that develop, provided reasonable care and precautions are followed, and I hereby release them of any liability of any kind whatsoever arising from my dog's/dogs' attendance and participation at *Devil Dog Daycare, LLC*.
5. I further understand and agree that dogs can sometimes receive minor cuts, scratches and puncture wounds at daycare. Since the dogs are intermingling, there is a chance that your dog may contract a contagious condition such as kennel cough. Any problems that develop with my dog(s) will be treated as deemed best by staff, interns, volunteers or *Devil Dog Daycare, LLC*, at their sole discretion. A veterinarian will be contacted if deemed necessary, and I assume full financial responsibility for any and all expenses involved.
6. I further understand by allowing my dog(s) to participate in services offered by *Devil Dog Daycare, LLC* I hereby agree to allow *Devil Dog Daycare, LLC* to take photographs or use images of my pet in print form or otherwise for publication and/or promotion.
7. I further understand my dog(s) must be licensed in the town in which he/she lives.
8. I further understand that if my dog(s) is/are not picked up on time or by a date specified in a separate agreement, I hereby authorize *Devil Dog Daycare, LLC* to take whatever action is deemed necessary for the continuing care of my dog(s). I will pay *Devil Dog Daycare, LLC* the cost of any such continuing care upon demand by *Devil Dog Daycare, LLC*. I understand if I do not pick up my animal, *Devil Dog Daycare, LLC* will proceed according to the guidelines provided by the State of CT Section 49-70. I give permission for my dog to participate in daycare with other dogs, under State of CT 22-344-13 Dogs caged individually except for health or welfare reasons.
